The Make in Maharashtra Program has just started off fresh, and therefore not much data is available regarding the impact of the program itself.

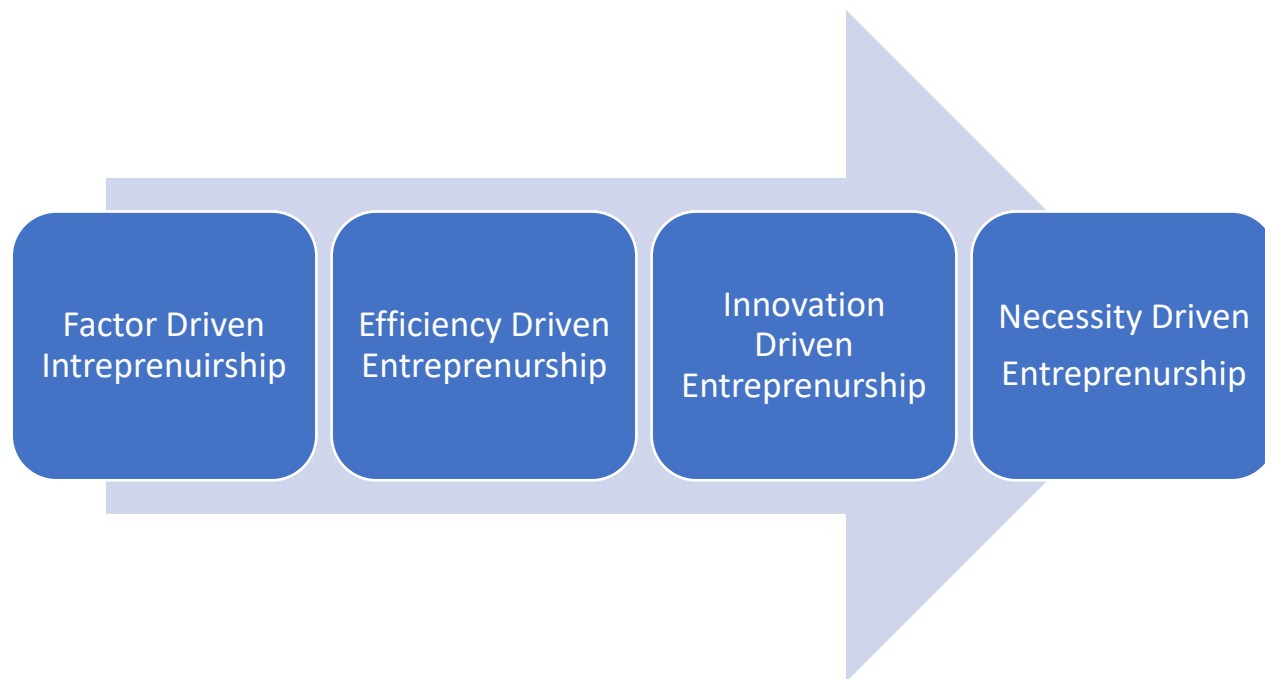
The study is conducted in one month and completely based on secondary data.

Progressive policies aimed at improving the businesses environment:

➤ **ONLINE SINGLE WINDOW SYSTEM:**

- ❖ Government has established & started MAITRI Online Single Window Portal, with the provision for single application which will be monitoring payment, tracking of about 44 industry related approvals across 16 departments.
- ❖ Government has also developed Mobile Application and Investor helpline to give support and facilitation to the investors.

➤ **TAX REFORMS :**

- ❖ Single working day will only be taken for the issue of single ID and Common Application Form for VAT, CST, Professional Tax, Entry Tax and Luxury Tax with all registration certificates.
- ❖ Mobile App is developed for the payment of Property Tax

Government has also taken initiative for the provision for e-payment of state taxes such as VAT, CST, Professional Tax, Entry Tax and Luxury Tax along with the provision for filing electronic tax returns.

➤ **LABOUR REFORMS:**

- ❖ For Labor laws in the State Self-certification scheme with Single Integrated Return Form started. Computerized Risk based Inspection of industries through a software based tool.

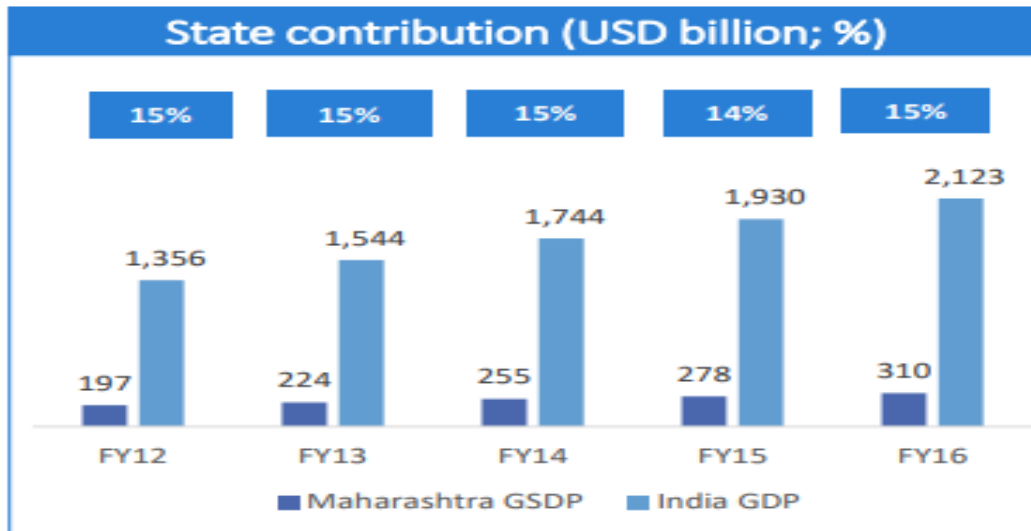

Interpretation: From the year 2015-2016 GDP contribution has drastically improved as compare to previous years due to valuable contribution of Make in Maharashtra Campaign.

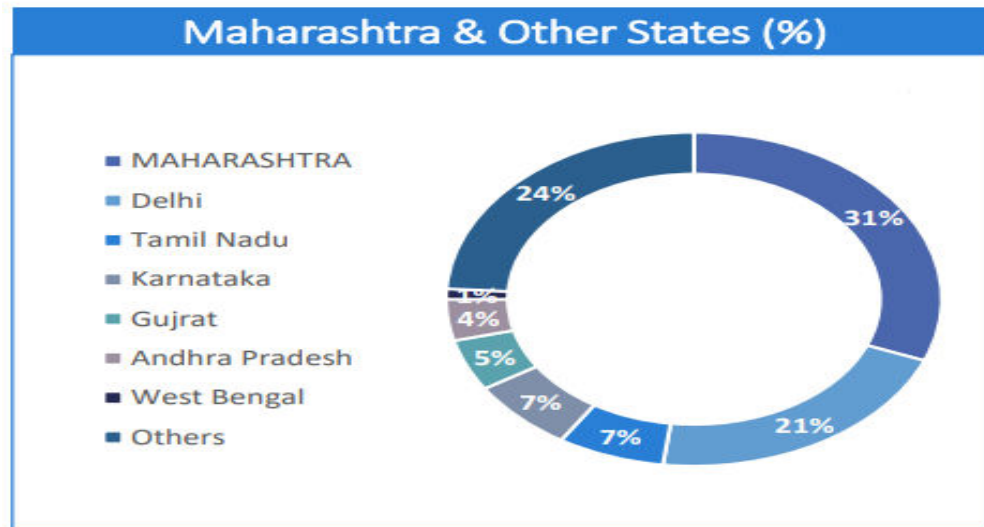
❖ **Maharashtra State GDP Contribution to India GDP:-**
