At IIMS the overall management of the institute has been entrusted to the Board of Governers (BOG), Academic Advisory Board (AAB) and Board of Studies (BOS) – in which faculty members are actively involved. Faculty play a crucial role in ensuring the implementation of our core values, quality policies, objective and strategic plan. Institute adopts decentralized governance model. The major decisions flows from top to bottom and thus are carried out through participative management. While taking a decision transparency is being followed at management, administration, financial and academic aspects. Organizational chart of International Institute of Management Studies clearly indicates the channel of communication, and various departments' roles and responsibilities and power dissemination across all the areas. Some of the functional committees managed by faculties are: Internal Quality Assurance (IQAC), Placements, Examination cell, Research, Library, Entrepreneurship cell, Antiragging, Women Empowerment, Social Responsibility, Cultural club to name a few. The Director at IIMS subsequently drives the resulting policy, strategy, resource allocation, and operations through the Governing body of these committees. Societal impact and responsibility are assigned prime importance. IIMS is devoted to contributing towards sustainable socioeconomic development through globally competitive standards. The institute has created various levels for operational autonomy. Institute is actively involved in promoting a culture of participative management. # **Delegation of Financial Powers**

Based on the recommendations made by the Finance Committee, the Management Committee of the institute has decided to delegate some of the financial power to the Director, Head of

Department for purchase of books, organizing Guest lectures, seminars, attending to Faculty Development Programs, Seminars, Conferences, Presentation of Papers, departmental meetings, Placement Expenses, Promotion expenses, purchase of consumables, Alumni meets etc. These powers will be exercised only by the authorized person and such powers have been delegated subject to the following the conditions

- 1) All expenditure should be within the annual approved budgetary grants. Delegated powers are to be exercised subject to the limits specified.
- 2) All the relevant rules, procedures and instructions shall be followed to ensure transparent and cost-effectiveness.
- 3) For operational convenience even if such powers have been sub delegated by the designated authority, such concerned authority still holds the responsibility for such expenditure

#### Grievance redressal mechanism

For any complaint and grievances, International Institute of Management Studies (IIMS) has a definitive and transparent Redressal mechanism. IIMS has online as well as offline grievance redressal system. Online system is linked to the IIMS website for students, and for teaching and non-teaching staff members. Complaint boxes are installed on prominent locations. On receiving the complaint, the Coordinator schedule a Grievance Redressal Committee meeting immediately. The committee member will proceed with the hearings from the victims (staff or student). If required the committee members interact with the parents as well. The necessary actions are taken by the committee and ensures that the problem has been resolved in a timely manner. After resolving the grievance, the report of the problem will be submitted to Director. Examination related griviences are handled by the examination committee and resolve the exam related issues on immadiate basis.

The grievance needs to be redressed and disposed-off as soon as possible, not exceeding 24 hours from the date of receipt. However, under some circumstance where policy decision is needed, the subject matter may be referred to the Director with request for direction and guidance.

The committee to oversee the student grievances is constituted by Staff members as well as students for impartial and thorough restitution. The members of the Student Grievance Redressal committee are as mentioned below:





Fig. Exam Related Grievance Redressal Process




Fig. Awareness of IIMS Policies
